Goals Being able to prepare financial statements according to IFRS.  
 -Understanding the rationale behind accounting methods and disclosures required by IFRS.  
 -Understanding the pros and cons of (allowed) alternative treatments.

Description This course provides an in-depth treatment of various advanced financial reporting methods that play a major role in the financial reporting of multi-national companies. It covers both measurement and (footnote) disclosure issues. Topics that will be discussed in detail include provisions and contingent liabilities, financial instruments, impairment, business combinations, and consolidation of (foreign) subsidiaries. Although a substantial part of the course will focus on the practical application of International Financial Reporting Standards (IFRS), the rationale behind the standards will also be discussed using insights from academic literature.
